#### **SPECIFIC BEQUEST**

## Specific amount

"I bequeath to the Corporation Archiépiscopale Catholique Romaine de Montréal, charity registration number 118876390RR0001, the sum of \$ ( specify amount ), without interest, in support of its mission."

### Specific property or asset

"I bequeath to the *Corporation Archiépiscopale Catholique Romaine de Montréal*, charity registration number 118876390RR0001, (\_specify percentage\_ ) % of my brokerage account number (\_specify account number ) held at ( specify name of financial institution )."

**UNIVERSAL BEQUEST** (the entirety of the property, where no specific bequests exist)

"After payment of my debts, I bequeath the entirety of all my real and personal property, including the proceeds of any life insurance policy not bearing a named beneficiary, to the *Corporation Archiépiscopale Catholique Romaine de Montréal*, charity registration number 118876390RR0001."

**RESIDUAL BEQUEST** (all or a portion of the remainder of the property following payment of debts and special bequests)

"I bequeath to X the sum of \$ (\_specify amount\_), without interest, and to the Corporation Archiépiscopale Catholique Romaine de Montréal, charity registration number 118876390RR0001, the residue of the entirety of all my real and personal property, including the proceeds of any life insurance policy not bearing a named beneficiary."

"After payment of my debts and the above-stated specific bequests, I bequeath the entirety of the residue of all my real and personal property, including the proceeds of any life insurance policy not bearing a named beneficiary, divided in equal proportion to X and the *Corporation Archiépiscopale Catholique Romaine de Montréal*, registered charity number 118876390RR0001."

"After payment of my debts and the above-stated specific bequests, I bequeath the entirety of the residue of all my real and personal property, including the proceeds of any life insurance policy not bearing a named beneficiary, to the *Corporation Archiépiscopale Catholique Romaine de Montréal*, registered charity number 118876390RR0001."

# **DESIGNATION OF A CONTINGENT BENEFICIARY** (in the event of the death of the primary beneficiary)

"I bequeath to X the entire residue of all my real and personal property, including the proceeds of any life insurance policy not bearing a named beneficiary.

If X should predecease me or die at the same time or within thirty (30) days following my death, or if he/she should disclaim this bequest or be unable to receive it lawfully, I bequeath the entirety of the residue of all my aforesaid real and personal property to the *Corporation Archiépiscopale Catholique Romaine de Montréal*, registered charity number 118876390RR0001."
